Agenda Item No. 2: Review and Consideration of Victoria Advocate's formal offer to settle Cause No. 2018-CV-3354-DC, Victoria Advocate Publishing Co. v. Calhoun Port Authority; In the District Court of Calhoun County, Texas; 135th Judicial District.

Attorney Bill Cobb of Cobb & Counsel informed the Board of a formal settlement offer which was made in a public forum by Mr. Chris Cobler, Editor of the *Victoria Advocate*. The settlement offer had two components; the first being that the Calhoun Port Authority admit that they violated the Texas Open Meetings Act regarding the agenda posting regarding the hiring of the legislative liaison. The second component was that the Calhoun Port Authority pay the *Victoria Advocate's* legal bills regarding this case in the amount of \$95,060.93. Pursuant to further review and discussion, a motion was made by Board Member Tony Holladay to refuse the offer of settlement. The motion was seconded by Board Secretary H. C. Wehmeyer, Jr. and by a vote of a show of hands, the motion carried unanimously.
