Agenda Item No. 2: Review and Consideration of bids received on September 11, 2019

for the Berthing Areas Maintenance Dredging – 2019 Project and further review and consider the

Corps of Engineers Option 2 of the current FY2018 Matagorda Ship Channel Maintenance

Dredging Contract No. W9126G18C0083 at a cost to the Port of \$1,400,000.00

Engineer Director David Knuckey recommended that the Port reject the bid form RLB Contracting and choose Option 2 from the Corps of Engineers at the cost of \$1,400,00.00 to the Port. Pursuant to further review and discussion, a motion was made by Board Secretary Tony Holladay to reject the initial bid from RLB Contracting and accept Option 2 from the Corps of Engineers in the current FY2018 Matagorda Ship Channel Maintenance Dredging Contract No. W9126G18C0083 at a cost of \$1,400,000.00. The motion was seconded by Board Member Luis De La Garza and the motion carried unanimously. Following this Special Board Meeting, the Army Corps of Engineers informed the Port Director that Option 2 was no longer an option and offered to include the berthing area maintenance dredging in the FY 2020 Matagorda Ship Channel Maintenance Dredging Contract that was scheduled to advertise in January of 2020 for a fee of \$300,000.00. This offer would be considered at the November scheduled Board Meeting.

Agreement with Fire Risk & Safety Technologies LLC for the Calhoun Port Authority Fire Protection System.

The Board Members reviewed a proposal from Fire Risk & Safety Technologies, LLC for an audit of the Port's various components of the fire protection system. Pursuant to further review and discussion, a motion was made by Board Secretary Tony Holladay to approve entering into a Professional Services Agreement with Fire Risk & Safety Technologies, LLC. The motion was seconded by Board Member Johnny Perez and the motion carried unanimously.
