SUMMARY

The Calhoun Port Authority (CPA) has the need for Engineering/Geotechnical Services for field exploration along the proposed rock dikes to be constructed parallel to the east jetty and west jetty of the Matagorda Ship Channel (MSC). The Port is seeking Requests for Qualifications (RFQ) from firms or individuals who can adequately demonstrate they have the resources, experience and qualifications to provide the Port with such services. The RFQ process will be in accordance with Section 2254.004 of the Texas Government Code.

SCOPE OF SERVICES

Activities with respect to this RFQ will include but may not be limited to the following:

 Geotechnical Field Exploration, Lab Testing & Geotechnical Data Report (GDR) for Matagorda Ship Channel Design Deficiency Project.

Reimbursements: There is no express or implied obligation for Calhoun Port Authority to reimburse Respondent for any expenses incurred in preparing a response to this Request for Qualifications, nor will CPA pay any subsequent costs associated with the provision of any additional information or presentation, or to procure a contract for these services.

Communication: CPA shall not be responsible for any verbal communication between any employee of CPA and any Respondent. Only written requirements and qualifications will be considered.

Payment Terms: Payment will be made in accordance with the negotiated contract.

Disclosure: There will be no disclosure of contents to competing Respondent's.

SUBMITTAL REQUIREMENTS

- 1. Proposals shall not exceed twenty-five (25) pages in length.
- 2. Submit five (5) copies of Proposal.

Proposals shall contain the following (INCLUDE ONLY INFORMATION REQUESTED BELOW):

- A letter of transmittal not exceeding one (1) page
- Location of the Firm offices that would provide the service
- Qualifications for the Prime Engineering Firm

History and organization of the firm, legal entity that contract will be entered into, primary contact, contact information, location of the office that the work will be performed, and the name and title of the person that is authorized to enter into a contract agreement (must be an officer, partner or member of the firm). Provide resumes of the key personnel being proposed as part of the Design Team.

Representative List of Projects

List three (3) completed comparable projects within the last five (5) years for which your firm has provided same or similar services requested. For each project, include the project name, location, direct client name and contact information, and a brief description of scope of services performed.

CPA reserves the sole right to evaluate the RFQs submitted; to waive any irregularities therein; or to reject any and all firms that submitted RFQs, should it be deemed in CPA's best interest.

This Request for Qualifications is not to be construed as a contract or a commitment of any kind.

All RFQ responses are required to be signed by an authorized representative of the responding entity. RFQ responses received unsigned will result in the submittal being declared unresponsive and may not be further evaluated.
